Helen K. Everson Fund	Benefits the residents of Amsterdam, New York- human services, better education for children, alleviate the human suffering, any other general charitable purpose
Hollis E. and Elizabeth H. Harrington Fund	50% of the Fund is to be used for the discretionary grantmaking purposes of the Foundation
James P. Heron Memorial Fund	Funds should go to small organizations
